Received an information that today i.e. 10/09/2023 at about 4.00 pm, youths of Manipur numbering about 1000 led by (1) Laishram Bidyananda Singh S/o L. Sanayaima Singh of Kakwa Ashem Leikai Oinam Thingel (8729878157), (2) Biondi Chandam S/o CH. Priyobrata Singh of Singajamei Sapam Leikai (6909593339), (3) Huidrom Tomthin of Singajamei Sapam Leikai and (4) R.K. Ichan Thoibi of Sagolband Tera forcefully trespassed in the residence of Shri Yumnam Khemchand Singh, Hon'ble Minister, Manipur situated at Yumnam Leikai. At that time the Minister himself was out of station in which the unruly youths forced the PRO (Public Relation Officer) of the Minister to contact in his mobile phone. The youths demanded the stand of Minister himself in the ongoing conflict between Meiteis and Kukis that has started from 3rd May, 2023 onwards in the State of Manipur. The youths further demanded to give the assurance of Minister himself in written for which he was intimidated if the stand was not clear.

Hence, a suo-motu case under FIR No. 763(9)2023 IPS u/s 188/488/506/34 IPC has been registered against the unruly youths mentioned above for investigation.
