Subject: - Complaint/ Report on the crimes of **looting, vandalism, arson attack and discrimination of Scheduled Tribes.**

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I am a Scheduled Tribe belonging to the Any Kuki Tribe, which is a recognized Tribe under the Constitution of India. And, I am a tenant of Shri. Lunkhosat Haokip, Kanaan Veng, Near AOC, P.O. & P.S. - ^{IPS} , District- Imphal East, Manipur.
2. That, on the 4th of May, 2023, at about 10:00 AM, we fled from our above mentioned rented house due to fear as a huge contingent of armed radical Meitei/ Meeteis suspected to be members of the Arambai Tenggol and Meitei Leepun were creating havoc and chaos all over the city of Imphal. And, took refuge at the 2nd Manipur Rifles until we were evacuated to Churachandpur on the 8th of May, 2023.
3. That, at the time of leaving/ fleeing from our rented house, we could not evacuate all our properties and left behind most of our properties including our 2 (two) wheeler- Maestro Scooty bearing Regn. No. MN01AM 2105 along with RC Book and Insurance papers/ documents; Educational Certificates of our Children; Six Indian Passport in the name of our family members namely-
 - (i) Mr. Telsing Lunpao Haokip, S/o Jangkholet Haokip
 - (ii) Mrs. Telsing Chongboi Haokip, W/o T. Lunpao Haokip
 - (iii) Ms. Ngailun, D/o T. Lunpao Haokip
 - (iv) Ms. Sinbi Mongneikim Haokip, D/o T. Lunpao Haokip
 - (v) Ms. Veineihoi Haokip, D/o T. Lunpao Haokip
 - (vi) Mr. Letgunsang Haokip, S/o T. Lunpao Haokip,
4. That, it may be reported here that the armed radical Meitei/ Meeteis suspected to be members of the Arambai Tenggol and Meitei Leepun, led by the Manipur Police Commando and the Indian Reserve Battalion (IRB), attacked our above said locality on the 5th of August, 2023 at about 9:30 PM, and looted/ destroyed all the properties left behind by us. A list of our properties looted/ destroyed/ burnt is given here under with its estimated costs. The total loss suffered is estimated to be about **Rs. 51,97,000/- (Rupees Fifty One Lakhs Ninety Seven Thousand) only.**
5. That, the miscreants were shouting slogans like- "KANGLEIPAK YAI PHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop

them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.

6. That, I am filing this information lately because the attack on our said locality at Imphal was attacked on the 5th of August, 2023 even though we left the place way back on the 4th of May, 2023.

In the given circumstances, I humbly pray you to kindly register an FIR/ ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
