Sir,

I am a law-abiding citizen of India and the present complaint is being filed against the accused person for taking up necessary legal action and punish her in accordance with law for his unlawful activities. The accused person claimed herself to be a self-style Freelance Journalist. And by using her social media platforms as a tool propagate misleading statements to the people so as to destabilise a democratically elected Government, disturb communal harmony by creating enmity among the communities and defame the State Government and one particular community. The accused intentionally made many false propaganda/ misleading statements so as to continue and escalate the present violence in the State of Manipur. Her unlawful activities are a threat not only to the security of the State but also to the Centre.

The accused person made her false propaganda/ statements by using her social networking page Makepeace Sitlhou's Profile | Freelance Journalist | Muck Rack/ Makepeace Sitlhou (@makesyoucakes) / X (twitter.com) run and operated by herself and the accused person has followers of about 17.1k on her X (formerly twitter) account. The accused used her X (formerly Twitter) account as a platform to fuel further

violence in the State of Manipur and to destabilise the Government by misleading and spreading false statement/ propaganda to her followers and general public/ common people.

Although the accused person claimed herself to a freelance journalist, she breaks the ethic of journalism and her writings/ statements are full of false, fabricated, sponsored and motivated statements. And on these given grounds the concerned authority may kindly look/ investigate the connection between the accused and the drug mafias/ narco-terrorist by initiating proper investigation against the accused person. And as her social media account is spreading false and concocted stories not only to her followers but also to general public, the same needs to be freeze/ block immediately so as to enable to restore peace and normalcy in the State of Manipur.

The complainant came to know such unlawful activities from the various social media including X (twitte.com) of the accused person on 07/09/2023 within the jurisdiction of Imphal Police Station, Imphal West, Manipur.

In the facts and circumstances, strict legal action may be taken up against the above-named accused person and her associates by registering a case so as to punish her in accordance with law.
