Sir,

I am a law abiding citizen of India and the present complaint is being filed against the accused person for taking up necessary legal action and punish him in accordance with law for his unlawful activities. The accused person by using social media platforms as a tool propagate misleading statements to the people so as to destabilise a democratically elected Government, disturb communal harmony by creating enmity among the communities and defame the State Government and one particular community. The accused intentionally made this false propaganda/misleading statements so as to continue and escalate the present violence in the State of Manipur. His unlawful activities are a threat not only to the security of the State but also to the Centre.

The accused persons made his false propaganda/statements by using his social networking page <https://twitter.com/paulphoenix1985> run and operated by himself and the accused person has followers of about 8,363 on his twitter account. The accused used his Twitter account as a platform to fuel further violence in the State of Manipur and to destabilise the Government by misleading and spreading false statement/propaganda to his followers and general public/common people.

He tweeted that "If Govt. is not facilitating this Genocide, who is ???". He meant the present violence in the State of Manipur and termed the deaths of one particular community as Genocide and blaming that the State Government is facilitating such deaths and the violence in Manipur is sponsored by Government. He further rtweets that present unsettling issue in the State of Manipur is sponsored by State Government. His

false statement/propaganda is intentionally made to incite one particular community to turn against the State Government and to topple such democratically elected Government. This is particularly intended to hurt the sentiments of different communities and their leaders. His misleading statements is intentionally made to instigate and create a sense of revolt against the State Government and his act is not only defame the Government but also a threat to the security of the State.

He also tweeted by calling Hon'ble Home Minister, Amit Shah ji and Hon'ble Chief Minister, N. Biren Singh as terrorist organisation without any supporting evidence. He also tweeted that "they sleep with dreams of more bodies, more blood and more money to earn the next day..." thereby attempting to tarnish the images of the Hon'ble Union Home Minister and Hon'ble Chief Minister in the eye of general public, thereby instigating different communities to hate the public functionaries belonging to Meitei and Gujarati communities to hurt the sentiments of these communities. In the enclosed old video in which the Hon'ble Union Home Minister and Hon'ble Chief Minister including BJP Manipur Pradesh President were having Manipuri traditional lunch and the accused has commented that all the people seen in the video are terrorist organizations. He made such comments on 20/08/2023 in "X" (formerly known as twitter).

In fact, the present violence in the State of Manipur which started from Churachandpur since 3<sup>rd</sup> May, 2023 thereby spreading to other parts of the State is a pre-planned act of certain groups of people which include illegal immigrants from Myanmar, Kuki Militants and others who opposed to the State Government policies against Drugs, Poppy cultivation, eviction of encroachers from Reserve and Protected Forests, implementation of National Register of Citizen (NRC). Those armed Kuki Militants burnt down many Meitei Houses, worship places, attacked and killed many Meitei civilians for no fault of them.

The accused in order to distort the history of Manipur and Meitei/Meiteis, intentionally tweets that Meitei/Meiteis are illegal immigrants and are mostly bloodlines of Bengalese and DNA testing will prove the originality of Meitei/Meitei community. His tweets are without any basis.

He also tweets that Meitei/Meitei are not civil human beings and labelled the community under the name tag of "Dumbos". He further tweets that the present situation is fuelled by Meitei/Meitei community against a Christian minority community. As such, he not only defamed the Meitei/Meitei community but also created enmity between Meitei/Meitei community and Kuki community. His intention is nothing to escalate the present violence in the State. Such act of the accused person is not of a prudent and responsible citizen who loves his fellow citizens.



In one of his tweets, on his twitter account the accused openly supported the poppy cultivation and illegal drugs business. There is a high possibility that the accused having nexus with the drugs mafia operating in the State of Manipur and on these given grounds the concerned authority may kindly look/investigate the connection between the accused and the drug mafias/narco terrorist by initiating proper investigation against the accused person and he may also been sponsored or funded by China or Myanmar based terrorist organisations and as such his credentials include bank transactions may be thoroughly investigated even by NIA or CBI or any such agency in public interest.

The complainant came to know such unlawful activities from the various social media including X (formerly known as twitter) of the accused person on 08/09/2023 within the jurisdiction of Imphal Police Station, Imphal West, Manipur.

In the facts and circumstances strict legal action may be taken up against the above-named accused person and his associates by registering a case so as to punish him in accordance with law.


