Today i.e 12/08/2023 at 11:00 pm received an information that at about 10:30 pm of date have heard a gunshot in and around Jalan crossing area ,Thangal Bazar and accordingly a team of City PS led by me rushed at the spot and pick up 4 persons from Bajaj Alliance Building near Jallan Crossing, Imphal. They were identified as 1) Rajiv Singh (32) S/o Basudev Singh of Thangal Bazar, Gun owner who fired the shot 2) Ajit Salam (28) S/o (L) S. Kumar Singh of Kanglatombi Bazar Board. 3) Thangjam Bijen Singh (30) S/o Th. Chaoba of Awang Sekmai 4) Ajmal Siddique (27) S/o Alamgirth of Thangal Bazar along with a license pistol and also recovered 10 live rounds, 2 empty cases and 1 projectile thereby endangering the life and properties residing at that area.

Hence, a Suo-motu case under FIR No. 50(08)2023 City-PS U/s. 506/34 IPC & 25(1-B) Arms Act has been registered for investigation.
