Sir,

I have the honour to report that at present I am working as Manager at SK. Construction, Thangal Bazar, MTC Building which is owned by one Suresh Jain of Thangal Bazar. At the 1st floor of MTC building we have office of SK. Construction and Manipur Trading Corporation (which is also owned by Suresh Jain). Today i.e. 20/8/2023 at @ 7 30 am the manager of MTC namely Sanju called me and told me that on the intervening night of 19-8-2023 at 7:00 pm to 20-8-2023 at 6:00 am some unknown person entered the office of SK. Construction & MTC and have stolen an amount of Rs. 10,29,300/- (Rupees ten lakh twenty nine thousand and three hundred) only which was kept inside the locker of the office by breaking the lock. The said amount was for MTC and is to be deposit in the bank. The unknown culprit have also stolen the DVR of the CCTV cameras installed at the office and the building.

It is therefore requested to kindly take necessary action to nab the culprits and recover the stolen amount at the earliest.
