

It is to bring your kind attention to the ethnic violence occurring and some residential areas of Kuki communities in Imphal were attacked by a large Meitei mob, we are compelled to leave for the safety of our life at Relief Camp 2nd MR, Imphal on the 4th May 2023, thereby cannot get accessed to both movable properties and immovable properties at Zomi-Villa, North A.O.C., Imphal, Manipur till date due to ethnic violence.

The details of both movable and immovable properties located at Zomi-Villa, North A.O.C., Imphal, Manipur belonging to the undersigned is listed below:

1. Homestead land bearing Dag Chitha .0317 and building structure worth Rs.3.00 crores under owner's name- (L) LamkholenSingson(husband of ChinkhonengSimte), located at Zomi-Villa, North A.O.C, Imphal, Manipur.
2. 1 LG Refrigerator worth Rs. 35000.00
3. 2 Sofa Set worth Rs. 120000.00
4. 5 Teak Almirah worth Rs. 350000.00
5. 1 microvave oven worth Rs.7000.00
6. 7 Wooden Beds worth Rs.270000.00
7. 1 Sony Smart TV worth Rs. 40000.00
8. One Godrej Almirah worth Rs. 35000.00
9. Utensils Worth Rs.200000.00
