I POLICE STATICAL

Subject: Report.

Sir,

I have the honour to report that on 15/09/2023 at around 10.40 am, 3 (three) unknown persons came in the house of my sister namely Potshangbam (0) Sanahanbi Devi aged about 58 years located at Kwakeithel Thokchom Leikai. They identified themselves as cadres of UNLF hired by Dr. Lenin Singh and Dr. Ranjita of Wangkhei Ningthem Pukhri Mapal. My sister is an organizer of a local Marup in which both the above noted Dr. Lenin Singh and Dr. Ranjita also joined the Marup. My sister has a dept of 20 lakhs + 29 lakhs to clear to both of them. However, on that day the three unknown youths took out a gun and pointed to the husband of my sister to remain quite. They demanded the money of both the doctors to be cleared at the instant. However, my sister argued that she could not give the money as of the instant moment and asked to give some time because of the disturbance in the ongoing conflict situation of Manipur. Then, the unknown armed youths locked the door of the house and started beating my sister with a road in which she received multiple injuries on her body. Hurriedly, the unknown youths left the spot after commission of the crime intimidating to all of the family members thereby advising to clear the money soon to the doctors. As such, my sister has been evacuated to Advanced Hospital and is undergoing medical treatment. Moreover, today i.e. 17/09/2023 at around 03:30 pm 5 (five) unknown youths came again and threatened to bring about a solution by giving away the money to Dr. Lenin Singh and Dr. Ranjita. It is highly suspected that the unknown youths have been hired by Dr. Lenin Singh and Dr. Ranjita.

It is therefore, requested kindly to take up necessary legal action against them.
