

Sir,

I have the honour to state that I am serving as an assistant professor at Moreh College, Moreh and residing in brother's residence in Moreh Ward No. 6 since 1995. I leave my room locked on 2<sup>nd</sup> May 2023 and I could not go there due to communal tension.

On 26<sup>th</sup> July 2023 the entire articles in the room have been looted by suspected Kuki militants at about 7:30 am to 10:30 am and doors and windows have been broken. The list of the looted articles are mentioned below: -


