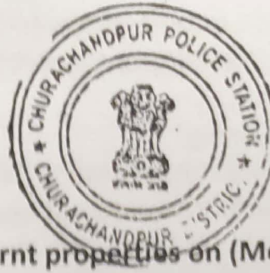

I am to bring to your notice that on the 4th May 2023, at 1 Pm

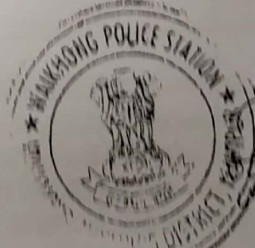
My residence (Owned/Rented) located at Aikang Village
