I would like to reiterate that on 4<sup>th</sup> May, 2023, around 3 PM my residence was attacked by miscreant mob led by Meitei Community whom were instigated by Arambai Tenggol and Meitei Leepun of valley based CSO.

Due to such attacked, fearing to lose our live, being in state of vulnerability, I along with my families have fled from our village rendering us in a state of homelessness. Presently, I have resided at Thingkangphai near Rayburn College.

I, therefore, request to your kind office to intervene and register a complaint against the perpetrators and abettor who commit such heinous act against me and my family for the ends of justice.
