

These criminals broke open my gate(s), destroyed and looted every valuable property from my "owned/rental" house, and premises worth Rupees 36,30,000 (approx) and they burnt down all the remaining things.

Therefore, with utmost respect, I request you to take strong actions against the perpetrators by registering an FIR under relevant sections of the Indian Penal Code.
