

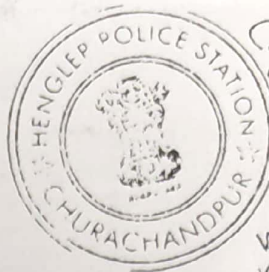

Sir,

I am to bring to your notice that on the 4th June, 2023 at 11:30 a.m, my residence (owned) located at Aihang Village, was attacked, destroyed, looted and burned by a group of Meeitei/Meiteis.

These criminals broke open my gate(s), destroyed and looted every valuable property from my owned house and premises worth Rupees 47,70,000 (approx) and they burnt down all the remaining things.

Therefore, with utmost respect, I request you to take strong actions against the perpetrators by registering an FIR under relevant sections of the Indian Penal Code.
