Sir,

With due respect, I would like to report a cognizable offence carried out against me and my family on 4<sup>th</sup> May around 2pm 2023. Wherein, a large gathering mob of Meitei Community conspired and instigated by Meitei Leepun & Arambai Tenggol of Valley based CSO's attacked on my/our Aihang village and started vandalizing, ransacking and burnt down my/our house rendering me in a state of homelessness. Fearing to lose of our lives and being in a state of vulnerability, I, along with my family members numbering 2 (male) 4 (female) had fled and now taking refuge and shelter at the resident of /Relief Centre Leijangkhopi.

That, the assets/properties and damages were estimated to Rs 13207000/-  
(one crore thirty two lakhs and seven thousand)

I, therefore, seek your kind intervention to register an FIR against the perpetrators and abators for their heinous acts carried out against me and my family.
