

Sir,

With due respect, I would like to report a cognizable offence carried out against me and my family on 4<sup>th</sup> May around 2 pm 2023. Wherein, a large gathering mob of Meitei Community conspired and instigated by Meitei Leepun & Arambai Tenggol of Valley based CSO's attacked on my/our Aikang vill. and started vandalizing, ransacking and burnt down my/our, house rendering me in a state of homelessness. Fearing to lose of our lives and being in a state of vulnerability, I, along with my family members numbering 1 (male) 3 (female) had fled and now taking refuge and shelter at the resident of /Relief Centre Leijangkhopi.

That, the assets/properties and damages were estimated to Rs 2972000/-.

I, therefore, seek your kind intervention to register an FIR against the perpetrators and abators for their heinous acts carried out against me and my family.
