Sir,

I the undersigned have the honour to state that the following few lines for your kind consideration and taking further necessary action.

That, on 06/06/2023 at around 8.30 pm my father namely Khuraijam Amu Singh (57) S/o (L) Kh. Luxmon of Waikhong Ningthoumanai Mayai Leikai is shot by some unknown miscreants while standing at near the gate of our residence located at Waikhong Ningthoumanai Mayai Leikai. The unknown person fled away immediately after shooting a shot at my father. Unfortunately no one was present at the scene of crime except my father himself. As a result gunshot my father was evacuated to Jivan Hospital for treatment. However he was then referred to Raj Medicity for further medical treatment.

I could not report to you regarding the incident in time as I along with my family members are engaged in the medical treatment of my father.

It is therefore requested, to kindly investigation into the matter and necessary legal action against the unknown culprits according to law.
