



Today i.e. the 15th June 2023 at 09:05 pm received a reliable information that on the same day at around 08:55 pm, a large number of persons including woman flock numbering about 300/400 have burnt down three vehicles i.e, (1) one Tata Truck (14 wheels) bearing registration No. AS01JC 6643 loaded machinery items, (2) one Tata S (6 wheels) bearing registration No. MN01 5247 loaded machinery items and one Bolero Pick up registration No. AS01PC 8604 loaded machinery items at Langmeidong Public Ground near Langmeidong Higher Secondary School, which are coming from Sugnu side towards Wabagai side driven by unknown drivers. All the drivers and occupants of the said vehicles were escaped from the spot. As a result of which the three vehicles were totally damaged.

Hence, a regular case has been registered on suo-motu case under FIR No. 30(6)2023 WKG-PS U/S 147/148/149/427/436 IPC for investigation.
