Subject: report.

Sir,

With due respect, I the undersigned have the honour to state the following few lines for your kind consideration and necessary action at the earliest.

That, on 13/06/202 at about 05:30 PM my daughter namely Wahengbam Arjentina Devi (22) along with my nephew namely Yengkhom Inaomacha Meitei (15) S/O Y.Gobind Meitei of Sugnu Awang Leikai left our residence and headed towards Wabagai Lamkhair Bazar for purchasing/buying medicines for grandson namely Tomthin (5) riding in an Activa 6G. And at around 7.30 pm I was informed by my nephew that in their way they met with one person namely Mayengbam Thoiba (30) S/O M. Inaocha of Lamjao Awang Leikai. And he further told me that a tussle happened between my daughter and Thoiba.

He further told me that some unknown youths of nearby area came and forcibly took the mobile phone of him and key of Activa 6G. And thereafter my daughter along with he and Thoiba were brought to Lamjao Awang Leikai Community hall forcibly against their will.

And Mayengbam Ningthemba and Mayengbam (O) Basanti assaulted my daughter by slapping at her face. Thereafter the persons namely Sorokhaibam Bimol (who holds an unauthorized gun), Sorokhaibam (O) Inaobi, Urikhinbam Echou, Mema, Elangbam Phaja (Ex Pradhan Candidate) Ningthoujam Thaninjaboi, Prabha, Ranjana and some others gathered at the spot. Sorokhaibam Bimol (who holds an unauthorized gun) threatened to kill by pointing an unauthorized gun to my daughter unless she accepts their plot (forceful marriage). And immediately, I along with my husband and my sister in law rushes to the spot.

Thereafter the mob so gathered held my daughter and Thoiba captive and lock them inside local club room from outside. I repeatedly requested them to unlock the room but they ignore my request. After some period of time, the room was then unlocked and we entered in the room. But they continue to plan the execution of forceful marriage "Keina Katpa". However, I along with my husband repeatedly requested them not to execute such type of forceful marriage as daughter was already married and having a child. In that Prabha started to assault me by holding a stick. Thereafter, they pulled my daughter's hair and kept in another separate room. Then, Sorokhaibam Inaobi again assaulted me by holding bamboo stick. Thereafter Elangbam Phaja (Ex Pradhan Candidate) told us to pay a sum of Rs. 50,000 as fine. But we denied their proposal and told them that fine was meaningless.

Thereafter, they assaulted me as well as my daughter by holding bamboo sticks and other deadly weapons. As a result of which my daughter was badly injured in her person. I requested them regarding the evacuation of my daughter to hospital. And I was also injured as a result of their assault.

In spite of injury, they arrange and executed force full marriage ceremony "Keina Katpa" of my daughter and Thoiba on Gun point. My daughter was also made to sign forcibly in a paper. Thereafter my daughter was sent to Thoiba's house as they were forcefully married. In the meantime a police team of Waikhong PS arrives and evacuated my daughter to Hospital for treatment.

I could not report to you in time as I along with my family are engaged in treatment of my daughter in the hospital.

It is therefore requested, kindly to take up legal action against them according to law.
