



Subject: Report.

Sir,

I have the honour to state that on 28/05/2023 at @ 2:30 pm, my uncle namely, Moirangthem Pele Meitei (35) s/o (L) M. John Meitei of Sugnu Makha Leikai, ward no.6 was hit by one bullet on his right shoulder while he run out from his house and crossing in front of Sugnu Sub District Hospital for Tangjeng village to save his life. It came to know that the bullet which hit on my uncle was fired by suspected to be unknown armed Kuki militants.

It is occurred on the same day that a large number of unknown armed miscreants suspected to be Kuki militants and their supporters attacked at the Sugnu Police Station with heavy volume of firing and they also burnt down/damaged many houses and valuable properties of Meitei communities inhabited in different places of Sugnu and Serou areas.

The complaint report was not informed in time due to current Law and Order situation. Therefore, OC/Sugnu Police Station is requested kindly take up necessary action into the unfortunate incident of my uncle.
