



Subject: Report for lodging an FIR against Colonel Ahlawat Commanding Officer of
37th Assam Rifles.

Sir,

I have the honour to state today i.e. 02/05/2023 at 08:30 am while I was preparing some important documents, one C/No.0193068 M. Samar Singh sentry of Sugnu Police Station, Kakching District, Manipur hurriedly came and informed me that a troop of Assam Rifles came in 3(three) bullet Proof vehicles and parked in front of our Police Station gate and SDPO Sugnu office gate with an intent to attack the Police Station and SDPO Office.

So, I along with our police personnel who were discharging their duty in and around the police station campus immediately went towards the Police Station gate to inquire about the matter. Then, it came to know that one bullet proof vehicle (Casper) was parked at the police station gate directly and blocked the gate, another bullet Proof vehicle (Casper) was parked at the SDPO/Sugnu gate directly without giving any prior information to the Officer-in-Charge of the Sugnu Police Station or other concerned authorities. The Assam Rifle personnel who were standing at the main gate of the police station did not allow me and our police personnel to move out from the police station campus with intent to wrongfully confining of all police personnel and also criminally intimidated us for facing dire consequence if we came out from our PS campus. Moreover, one more bullet proof vehicle (Casper) was also parked and blocked the main road of Sugnu Chakpikarong road in front of the Sugnu police station gate to stop the vehicles of security personnel which came towards the police station for obstructing their lawful duty and also restraining the free movement of all state police force and other security personnel.

Further, I saw that the troop of Assam Rifles led by Colonel Ahlawat, Commanding Officer of 37 Assam Rifles holding with sophisticated weapons took their position at different locations in front of Sugnu Police Station and SDPO Office Sugnu with an intent to attack the security personnel of Sugnu Police Station, SDPO Sugnu, CDOs and other three Additional SsP rank senior Officers who were stationed at SDPO Office Sugnu for discharging law and order duty.

But the police personnel of Sugnu Police station including Officer-in-charge, SDPO/Sugnu and his escort including Addl. SP (OPS)/KCG, Addl. SP (CPCR)KCG, Addl. SP(OPS)TBL and their escort teams also came out and there was a confrontation with exchange of some argumentative words with Assam Rifles team. Thereafter, Colonel Ahlawat, Commanding Officer of 37 AR and his team was withdrew/move back from their positions.

It is, therefore, requested to register a case against Colonel Ahlawat Commanding Officer of 37th Assam Rifles and take up necessary legal action against him.
