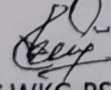

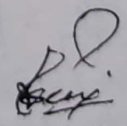

I the undersigned have the honour to state that the following few lines for your kind perusal and taking further necessary action.

That, on the 4th May 2023 at around 10:00 am unknown miscreants suspected to be Akambai Tenggot Kangleipak Kanba lup (KKL) Meitei lipum numbering about hundred hundred and thousand burnt down my residential houses and other properties located at Aihang Village, P.O. & P.S - Waikhong 795103 Chandel District, Manipur amounting to crores of worth properties remained ashes. The value of two houses properties burnt down is estimated to be around Rs 1 crores (Rupees one crore) approximately.

I could not report the incident to my concerned police station in the time due to the prevailing law and other situation of our state.

I therefore request your good office to kindly take up necessary action in this regard.
