



2. One Dressing Table worth Rs. 15,000/-
3. One Washing Machine worth Rs. 10,000/-
4. Two Double Bed worth Rs. 30,000/-
5. Four Trolley Bags with clothes and documents worth Rs. 60,000/-
6. Kitchen Items and Other Items in the house worth Rs. 50,000/-
7. Two Sofa Sets worth Rs. 40,000/-
8. Important Original Documents and Certificate
9. Approximate Value of One House is Rs. 7,00,000/-
(Two Bedroom, Hall, Kitchen with attached bathroom)
10. Miscellaneous Household Items worth Rs 5,00,000/-
