



Today i.e. On 04/06/2023 at 01:50 am, received a reliable information that on the same day i.e. on 04/06/2023 at about 01:45 am, large unknown armed miscreants suspected to be Kuki Militants attacked/ambushed upon Sugnu Police station and SDPO Office Sugnu as well Shri Binoy Chongtham, MPS Addl. SP (OPS)Kakching, Shri A. Romendro Singh, MPS Addl. SP(CPCR)Kakching, Shri Wangkhomba Angomcha Addl. SP(OPS)TBL including CDO/KCG team and CDO/TBL team who were discharging their law and order duty at different locations of Sugnu areas by indiscriminate heavy volume of firing from Nazareth and Sugnu Tribal villages side using with sophisticated weapons including Sniper guns with an intent to kill the security personnel. The security personnel also retaliated on firing to save their life and protect the properties of Sugnu Police Station and SDPO Office Sugnu.

Hence a Suo motto case has been registered under FIR No.35(6)2023 SGN-PS U/s 307/400/506/34 IPC & & 25 (I-C)A. Act. against the unknown armed miscreants suspected to be Kuki Militants for taking up necessary legal action.
