

Today i.e. On 04/06/2023 at 02:00 pm, received a reliable information that on the same day i.e. on 04/06/2023 at about 01:50 pm, a large number of unknown persons suspected to be Meitei community had entered the Nazareth village area and organized an unruly and irate mob with holding dangerous weapons and burnt down/damaged many houses and valuable household properties of Kuki community at Nazareth village, Sokom village, and other nearby villages. As a result of which unknown miscreants suspected to armed Kuki militants also fired indiscriminately towards the mob members using with sophisticated weapons with an intention to kill mob supporters. As a result of which information was given to fire Service station, Sugnu to stop the fire and combined teams of District Police Kakching, CDO/KCG team and CDO/TBL team immediately rushed towards the Nazareth village. However, the mob was found already been dispersed themselves.

Hence, a Suo motto case under FIR No.36(6)2023 SGN-PS U/s 148/149/295A/436/427/307/400/ 120B/34 IPC & 25(1-C) A. Act. has been registered against the unknown culprits for taking up necessary legal action.
