



Subject: Report.

Sir, I have the honour to report that on 28/05/2023 at about 02:00 pm, large number of unknown persons of different aged groups including male and female numbering about 1500/2000 were found organizing an unruly and irate mob at Wapokpi bazaar area while I along with 31 MR personnel of 8th MR was proceeding from Imphal towards Sugnu Police Station on departmental vehicle to report to OC/SGN-PS for discharging law and order duty at Sugnu PS jurisdiction vide order No.B-1/16/23-IGP(Ops)/670 dtd 10/05/2023. In that our vehicle was stopped by the mob supporters. While I was talking with mob supporters about the present law and order situation, but all the MR personnel including me were rounded by the mob supporters and some arrogant unknown mob supporters forcibly snatched away the following arms and ammunitions from the MR personnel of our team and the unknown culprits had escape along with the arms and ammunitions by taking the advantage of huge crowd.

Particulars of the arms & ammunitions snatched.

1. AK Rifle having butt No.B-37 along with 3 Magazine and 90 live round issued in Hav No.062007594 Wirshing Moyon.
2. AK Rifle having butt No.110 along with 3 Magazine and 90 live round issued in Hav No.09971177 D. Romio Maring.
3. AK Rifle having butt No. H-16 along with 3 Magazine and 90 live round issued in Hav No.1299165 Ch. Mephun Maring.
4. INSAS Rifle having butt No.H-1 along with 3 Magazine and 60 live round issued in Riflemen No.05066511 Kh. Sobi Chothe.
5. INSAS Rifle having butt No.171800789 along with 3 Magazine and 60 live round issued in Riflemen No.08201112 KL. Ramjathing Anal.
6. 11 (eleven) INSAS LMG Magazine loaded with full round.
7. 800 rounds of 5.56X45mm.
8. 720 rounds of 7.62X39mm.
9. 70 rounds of 9mm.
10. One full loaded AK Magazine issued in Riflemen No.08200676 Surjit Singh.
11. Three full loaded Ex-Caliber issued in Riflemen No.082010127 Kaku John.
12. One full loaded AK Magazine issued in Riflemen No.082010116 M. Marungthar.

I along with my team tried our best level to recover/find out our Arms and ammunitions by collecting information from different angles. But unable find out/recover till date.

In this regard, I request you to take up necessary legal action at the earliest.
