





Today i.e. 05/06/2023 at 05:30 pm, received an reliable information that on the same day at @ 05:20 pm, one individual namely, Laishram Binod Singh S/O L. Jane Singh of Wangjing Awang Leikai was succumbed to bullet injury and another four individuals namely, (1) Salam Romeo Singh (23) S/o S. Naobicha Singh of Serou Mamang Leikai, (2) Kshetrimayum Okendro Singh (28) S/o (L) Ksh. Sundramohan Singh of Serou Mayai Leikai, (3) Yumlembam Korou (21) S/o Y. Manao of Serou Mamang Leikai and (4) Johny S/o Mombi of Wangjing Awang Leikai were sustained bullet injuries on their persons due to the indiscriminate firing by suspected unknown armed Kuki militants while the individuals went at the house of Yumlembam Korou (21) on a gypsy to check the present condition of his house and other household properties which was burnt down by suspected armed Kuki militants and their supporters. Moreover, the Gypsy which was used by them which was parked at Serou Mamang Leikai area was also burnt down by the unknown culprits. The four individuals sustained bullet injuries were evacuated to Hospital for medical treatment.

Hence a Suo motto case under FIR No.39(6)2023 SGN-PS U/s 302/307/326/400/436/427/506/34 IPC & 25 (I-C)A. Act. has been registered against the unknown armed culprits for taking up necessary legal action.
