





Today i.e. on 06/06/2023 at 5:00 am, received a reliable information that on the same day i.e. on 06/06/2023 at about 04:40 am, large number of unknown armed miscreants suspected to be Kuki Militants attacked/ambushed upon the combined security personnel of Singtom OP team, 8th IRB team, CDO team, BSF team and AR team by indiscriminate heavy firing using Sophisticated weapons including Sniper guns from different direction with an intent to kill the security personnel while the security personnel were staying at Serou Practical Higher Secondary School for discharging their law & order duty. The combined security personnel also retaliated by firing against the suspected unknown armed kuki Militants. In that incident, one C/No.082010906 Ranjit Yadav (36) of 163 Bn of BSF, "A" Coy and two security personnel of 37 AR, namely, (1) DK Gogoi, Riflemen/GD No.5002006 of Arunachal Pradesh and (2) TK Ding Simte, Riflemen/GD No.5000257 of New Lamka, CCpur District were sustained bullet injuries on their persons due to the indiscriminate firing by unknown armed persons suspected to be Kuki militants. The three injured personnel were evacuated to Hospital for medical treatment.

As a result of which, a Suo motto case under FIR No.40(6)2023 SGN-PS U/s 307/326/400/120-B IPC & 25(1-C) A. Act. has been registered against the unknown culprits for taking up necessary legal action.
