Subject: Report

Sir,

I have the honour to report that on 06/06/2023 at about 5:30 am, received a reliable information from source that some armed miscreants suspected to be Kuki militants are loitering at Thingkangphai Village area with an intention to attack the security personnel with holding sophisticated weapons. On receiving the information, superior officers were informed and under their supervision, a combined team security personnel i.e CDO/KCG team led by SI Th. Robindro Brown (Golf-61), HC. Kh. Umakanta Singh (Kilo-75), HC. L. Rohit Singh (Kilo-79), and CDO-TBL team led by SI Ramesh Singh (Golf-58), ASI S. Kumar Meitei (Golf-38), Hav. Paraj Khuman (Golf-93), 37 Assam Rifles teams and a special CDO team under the overall supervision of Shri Wangkhomba Angomcha Addl.SP(OPS) Thoubal District immediately rushed at the said area. When the combined security forces reached at the said area, unknown armed persons suspected to be Kuki militants attacked/ambushed upon the security personnel by heavy volume of firing from different direction using with sophisticated weapons including Motar shell. The combined security personnel also retaliated against the suspected Kuki militants. After about 10 hours of heavy exchange of gun fight between the two sides, security forces covered the area where the kuki militants used to take position to attack security forces. Security personnel conducted searched in some suspected houses and other location. In that 1(one) ammunition box containing 4 (four) nos. of 2" motar Shell, 2(two) unrecognized empty cases and 1(one) missed fired Lathod Shell were recovered from a room of the house of Lunminthang Haokip, IAS, Retd. DC resident of Thingkangphai Village under the jurisdiction of SGN-PS. So the recovered items were seized by observing formalities at 02:30 pm.

It is therefore, requested kindly to take up necessary legal actions against the culprits.
