Subject:- Report.

Sir,

I have the honour to report that combined team of security force under the overall supervision of Shri Themthing Ngasangva, IGP Zone-I comprising with Brigadier Y.S. Sajwan Commander 28<sup>th</sup> Sector Assam Rifles, Colonel Digvijay Ahlawat C/O 37 Assam Rifles, Shri Shrey Vats, IPS, SP-KCG, Shri Wangkhomba Angomcha, MPS Addl. SP(OPS)TBL, Shri Binoy Chongtham, MPS, Addl. SP(OPS)KCG, Shri Praveen Chander, AC, 163(A-Coy) BN BSF, Shri Ng. Anthony Suresh, MPS, SDPO-SGN and team of CDOs KCG/TBL, Spl. CDO unit Khabeisoi and a team of Sugnu PS conducted search operation at Serou Part-II, Serou Part-III and Thingkangphai village area w.e.f. 08:00 am to 11:45 am of 07/06/2023 in order to arrest the unknown armed miscreants and UG elements who were involved in the attacked/ambushed upon the security personnel using with sophisticated weapons few days back and to sanitized the area from UG element.

During the search operation, about 300 houses (including abandoned) have been searched and about 150(one hundred fifty) individuals were verified. There was no arrest during the operation.

The following incriminating items suspected to be kept concealing by unknown armed militants/UG elements to attack the security personnel were recovered from different places during the search operation and seized by observing formalities.

Details of the seized items are as follows:

1. 12 nos. of local made pipe explosives launcher.
2. 1 handbag containing medicine kit(red handbag).
3. Gunpowder with small pieces of iron (inside the plastic bucket orange color).
4. One blue plastic basket containing 69 empty cases of different calibers.
5. Two empty bags black in colour.
6. Electric wire blue in colour.
7. One notebook having black cover.
8. One notebook of "green valley" company.
9. Two page sheets along with one paper writing board.

It is therefore, requested to you for taking further necessary legal action against the unknown culprits.
