



Subject:- Report.

Sir,

I have the honour to report that today i.e. 08/06/2023 a combined team of security force under the supervision of Colonel Digvijay Ahlawat C/O 37 Assam Rifles, Major Netar of 37 AR, Shri Binoy Chongtham, MPS, Addl. SP(OPS)KCG, Shri Manvendra Singh, AC, 167(B-Coy) Bn BSF and team of CDOs KCG/TBL and a team of Sugnu PS conducted search operation at Sugnu Tribal Village, Sahumphai Village, Sokom Village and Nazareth village area w.e.f. 08:50 am to 11:50 am in order to arrest the unknown armed miscreants and UG elements who were involved in the attacked/ambushed upon the security personnel using sophisticated weapons and to sanitized the area from UG element.

During the search operation, about 280 abandoned houses have been searched. There was no arrest during the operation.

The following incriminating items suspected to be kept concealing by unknown armed militants/UG elements to attack the security personnel were recovered from different places during the search operation and seized by observing formalities.

Details of the seized items are as follows:

1. 10(ten) Nos. of local handmade pipe explosives launcher.
2. 2(two) Nos. of local made single barrel gun.
3. 1(one) DBBL gun, B/No.67928-18-IN marked as Stallion Light.
4. 33(thirty three) Nos. of empty cartridges of different calibers.
5. 1(one) Remnant of 2" (two inches) motor.
6. 19(Nineteen) Nos. of empty cartridges of SBBL/DBBL gun.
7. 1(one) local wooden handmade(not finished) gun.
8. 1(one) name plate in the name of Thangthang Kuki.
9. 1(one) SBI ATM card in the name of Sokholen Haokip.
10. 1(one) unknown car key marked as "Terminator"

It is therefore, requested to you for taking further necessary legal action against the unknown culprits.
