




With utmost regret and deeply pained by the recent carnage instigated by the Meitei radicals led by the self-styled Arambai Tenggol and Meitei Leepun in Manipur along with the local irate mobs of Waikhong area, I am to submit herewith a First Information Report (FIR) on well pre-planned attacks and destruction by the Meiteis led by these organisations by burning of all the 90 houses of Aihang village, Chandel Sub-Division, Chandel District on the unfortunate day of 4<sup>th</sup> May, 2023 around 9:30 AM.

Date of event : 4<sup>th</sup> May 2023

Estimated Loss of property: Rs. 150.00 Lakhs (Approx.)
