

Subject:- Report.

Sir,

I have the honour to report that today i.e. 10/06/2023 a combined team of security force under the supervision of Colonel Digvijay Ahlawat C/O 37 Assam Rifles, Major Netar of 37 AR, Major L. James of 37 AR, Major Jaivrat Singh of 37 AR, Shri Ng. Anthony Suresh, MPS SDPO-SGN, CDO unit Kakching led by HC M. Lakshman Singh(Golf-32), CDO unit Kakching led by Hav. Ksh. Santikumar Singh(Golf-84) and a team of Sugnu PS conducted search operation at Khongnang Pheisabi, Utangpokpi, Moltincham, Kotsophai, Khupijang and Singtom Villages area w.e.f. 09:00 am to 12:15 pm in order to arrest the unknown armed miscreants and UG elements who were involved in the attacked/ambushed upon the security personnel using sophisticated weapons and to sanitized the area from UG element.

During the search operation, about 200 abandoned houses have been searched. There was no arrest during the operation.

The following incriminating items suspected to be kept concealing by unknown armed militants/UG elements to attack the security personnel were recovered from different places during the search operation and seized by observing formalities.

Details of the seized items are as follows:

1. 8(eight) Nos. of local handmade pipe explosives launcher.
2. 11(eleven) Nos. of empty cartridges.
3. 2(two) Nos. of empty cases of 5.56mm ammunition.
4. 1(one) No. of empty case suspected to be AK ammunition.
5. 1(one) No. of high explosive (HE) charge (Motar).
6. 1(one) No. of high explosive (HE) head cover(Motar).
7. 2(two) Nos. of high explosive (HE) container (Motar).
8. 1(one) Airgun marked as "NEW LIGHT ART WORKS" 1572
9. Some small pieces of iron.
10. 1(one) plastic container containing Airgun rounds.

It is therefore, requested to you for taking further necessary legal action against the unknown culprits.
