



Subject:- Seizure of weapons, ammunitions and war like stores.

Sir,

I have the honour to report that today i.e. 11/06/2023 at 05:00 am, a team of 37 Assam Rifle led by Major G.S Pal and Major Ranjit Singh conducted searched operation in the hilly areas adjoining L. Thingkangphai Village in order to flush out unknown armed miscreants, UG elements and their remnants who were involved in the attacks/ambushes on the security personnel using sophisticated weapons.

During the search operation, the following incriminating items suspected to be kept at concealed locations inside thick undergrowth around L. Thingkangphai Village by unknown armed militants/UG elements which can be utilized to carry out attack on security personnel were recovered and seized by observing formalities at 10:00 am.
