





Sir,

I have the honour to report that today i.e. 12/06/2023 a combined team of security force under the supervision of Shri Binoy Chongtham, MPS, Addl. SP(OPS)KCG, AC Praveen Chander of 163 Bn BSF "A Coy" and a team of Sugnu PS conducted search operation at Serou Makha Leikai general area w.e.f. 08:30 am to 10:30 am in order to arrest the unknown armed miscreants and UG elements who were involved in the attacked/ambushed upon the security personnel using sophisticated weapons and to sanitized the area from UG element.

There was no arrest during the search operation. However, recovered 3(three) Nos. of local handmade pipe explosives launcher from Serou Makha Leikai near adjoining river bank of Jalenkot village, CCPur District which is kept concealing by unknown armed suspected to be Kuki militants/UG elements to attack the security personnel and seized by observing formalities.

It is therefore, requested to you for taking further necessary legal action against the unknown culprits.
