





Today i.e. on 12/06/2023 at 01:40 pm, received a reliable information that on the same day i.e. on 12/06/2023 at about 01:30 pm, a large number of unknown persons suspected to be Meitei community unlawfully assembled at Nazareth village area with an intent to commit illegal activities. Information further revealed that, the unknown persons which unlawfully assembled had organized themselves as unruly and an irate mob started destroying the remaining portion of the houses which were already burnt down by unknown persons on 29/05/2023. Immediately a police team including SI M. Minabanda Singh, Shri A. Romendro Singh, MPS, Addl.SP(CPCR)KCG, Shri Binoy Chongtham, MPS, Addl.(OPS)KCG and N. Gunamani Singh, MCS, EM, SDC-Sugnu rushed to the spot. Many warning to disperse the mob has been given to the mob supporters but they refused to disperse the mob. At last Executive Magistrate, N. Gunamani Singh, MCS, EM, SDC-Sugnu ordered to disperse the mob. Accordingly, the police team fired some rounds of Tear Smoke Shell to the mob supporters and the mob was dispersed.

Hence, a Suo motto case under FIR No.48(6)2023 SGN-PS U/s 143/147/148/149/427/447/34 IPC has been registered against the unknown culprits for taking up necessary legal action.
