



Subject:- Report.

Sir,

I have the honour to report that today i.e. 13/06/2023 a combined team of security force under the supervision of Shri Binoy Chongtham, MPS, Addl. SP(OPS)KCG, 37 Assam Rifle team led by Major Raghav and Major Rana, "D Coy" 136 BN BSF led by Inspt. Ajit Singh, "B-Coy" 167 Bn BSF led by ASI Nanaji Singh and HC G Anilkumar and a team of Sugnu PS conducted search operation at Sugnu Tribal, Sokom Village, Nazareth village and its adjoining hilly areas w.e.f. 08:30 am to 02:00 pm in order to arrest the unknown armed miscreants and UG elements who were involved in the attacked/ambushed upon the security personnel using sophisticated weapons and to sanitized the area from UG element.

During the search operation, the following incriminating items suspected to be kept concealing by unknown armed militants/UG elements to attack the security personnel were recovered from different places during the search operation and seized by observing formalities.

Details of the seized items are as follows:

1. 2 empty cases of Rubber Bullet.
2. 2 empty cases of Lathode shell.
3. 5 Improvised local handmade pipe explosive launcher.
4. 17 empty cases of different calibers.
5. 2 misfired rounds.

It is therefore, requested to you for taking further necessary legal action against the unknown culprits.
