I have the honour to report that today i.e. 13/06/2023 a combined team of security force under the supervision of Major G.S Pal of 37 AR, Inspt. S. Birla Singh, OC/CDO-KCG, AC Praveen Chander of 163 Bn BSF "A Coy" and a team of 8th IRB personnel conducted search operation at Thingkangphai Village, Serou Part-II, Serou Part-III and its adjoining areas w.e.f. 08:30 am to 01:30 pm in order to arrest the unknown armed miscreants suspected to be Kuki militants and UG elements who were involved in the attacked/ambushed upon the security personnel using sophisticated weapons and to sanitized the area from UG element.

- 6. 1(one) No. of olive green cap.
