Sir,

I have the honour to report that today i.e. 14/06/2023 a combined team of security force under the supervision of Shri A. Romendro Singh, MPS Addl. SP(CPCR)KCG, 37 Assam Rifle team led by Major Jaivrat Singh Raghav, AC Mohit Meena of 136 Bn BSF "D Coy", ASI Md. Aminul Haque of Sugnu PS, Hav. Somenjit Singh, CDO-KCG and Hav. N. Chaoba Singh, CDO/KCG conducted a search operation at Sahumphai Village area w.e.f. 09:00 am to 12:00 pm in order to arrest the unknown armed miscreants and UG elements who were involved in the attacked/ambushed upon the security personnel using sophisticated weapons and to sanitized the area from UG element.

During the search operation, 2 Nos. of local handmade pipe explosive launcher which is suspected to be kept concealing by unknown armed militants/UG elements to attack the security personnel were recovered from Sahumphai Village area and seized by observing formalities.

It is therefore, requested to you for taking further necessary legal action against the unknown culprits.
