I have the honour to report that today i.e. 14/06/2023 a combined team of security force under the supervision of Shri A. Romendro Singh, MPS Addl. SP(CPCR)KCG, 37 Assam Rifle team led by Major Jaivrat Singh Raghav, AC Mohit Meena of 136 Bn BSF "D Coy", ASI Md. Aminul Haque of Sugnu PS, Hav. Somenjit Singh, CDO-KCG and Hav. N.
