Subject:- Report.

Sir,

I have the honour to report that today i.e. on 15/06/2023 a combined team of security force comprising 37 AR, 163 Bn BSF (A-Coy), 184 Bn BSF (E-Coy), OC/CDO-KCG, CDO/TBL and 8th IRB conducted a search operation at Serou Part-III and Chakpi Molbem village areas from 08:00 am to 01:00 pm in order to arrest the unknown armed miscreants and UG elements who were involved in the attacked/ambushed upon the security personnel using sophisticated weapons and to sanitized the area from UG element.

During the search operation, the following incriminating items suspected to be kept concealed by unknown armed militants/UG elements to attack the security personnel were recovered from Chakpi Molbem area and seized by observing formalities.

Details of the seized items are as follows:

1. 2 Nos. of local handmade pipe explosive launcher.
2. 1 No. of camouflage jacket.
3. 8 Nos. of empty cases of cartoons.
4. 1 No. of camouflage full shirt.
5. 1 No. of Gun cleaning iron rod.

It is therefore, requested to you for taking further necessary legal action against the unknown culprits.
