I, the undersigned have honour to state that a large numbers of Kuki Militants having with deadly sophisticated weapons have stormed and they burnt down my house and all my properties (list enclosed) were lost due to the ethnic clash on date 28/05/2023 at about 07:30 am. Also I got multiple bullet injuries on my left leg and my son Kongkham Topon also got bullet injury at his right lower shoulder. All my family members are mentally disturbed and unrest for our future.

It is therefore, request you kindly to initiate and take necessary legal action against the matter according to law for the ends of justice.

I would be highly obliged for your kind consideration.
