

Sir,


I have the honour to report that today i.e. on 17/06/2023 a combined team of security force comprising Shri A. Romendro Singh, MPS, Addl.SP(CPCR)KCG, Shri Ng. Anthony Suresh, MPS, SDPO-SGN, Hav. O. Somenjit, G45- CDO/KCG, ASI Md. Aminul Haque of Sugnu PS, 37 AR Sugnu along with their escort parties conducted a search operation at Khongnang Pheisabi village and Utangpokpi village areas starting from 12:30 pm to 02:00 pm in order to arrest the unknown armed militants especially UKLF (United Kuki Liberation Front) and UG elements who were involved in the attack/ambush upon the police and CDO personnel using sophisticated weapons and also to sanitize the area from them.

During the search operation, (1) 23 empty cases of different calibers, (2) Nut, bolt and some pieces of iron rod which are suspected to have been used in local handmade pipe explosive launcher and (3) one camouflaged magazine pouch marked as "CHQ 14703998" on the back side were recovered from the Community Hall near the play ground of Utangpokpi village. Hence, the above items were seized and handed over to you by observing formalities.

It is therefore, requested to you for taking further necessary legal action against the unknown culprits.
