I am to informed you that today i.e. on 18/06/2023 at @ 10:10 am, I, Ng. Anthony Suresh, MPS, SDPO-SGN along with my escort team was on patrolling duty/checking of deployment of Police/VDF/CDO personnel from St. Joseph Higher Secondary School to Serou Practical High School in c/w Great June Uprising Day, 18th June organized by UCM & AMUCO. At about 10:30 am we came across 2 country made pipe Gun (Pipe explosive Launcher) at Khongnang Pheisabi village. The above pipe Guns were suspected to have been used by the unknown Kuki UGs/UKLF cadres for attacking the police and CDO personnel by using other sophisticated weapons. The same were seized at 10:46 am. The seized items are handed over to you by observing formalities.

It is, therefore, requested to kindly take up further necessary legal action against the unknown culprits.
