I have the honour to report that today i.e. on 19/06/2023 a combined team of security force under the supervision of Shri Binoy Chongtham, MPS, Addl. SP(OPS)KCG, Shri A. Romendro Singh, MPS Addl. SP(CPCR)KCG, 37 Assam Rifle and 15 Assam Rifle led by Lt. Colonel Kuldeep, 136 Bn BSF "D Coy" led by Assistant Commandant Mohit Meena, CDO-KCG teams and a team of Sugnu PS conducted search operation at Kotsophai Village and Khupijang village areas from 09:30 am to 01:00 pm in order to arrest the unknown armed miscreants and UG elements who were involved in the attacked/ambushed upon the security personnel using sophisticated weapons and to sanitized the area from UG element.
