



With you respect I, the undersigned have the honour to state that I am a Present Residence of Serou Makha Leikai, Kakching District P.O./P.S.Sugnu 795101,Parmanent Residence of Wangoo Naodakhong Awang Leikai, Bishnupur District, Manipur 795133. That on the 28<sup>th</sup> May 2023 at around 3:00 am, some unknown miscreants suspected to be Kuki tribes and Kuki Militants stormed our locality with arms and other incriminating weapons. They have burn down and torched my resident House and Computer Centre and household items Furniture(s)/Food items/Jewelleries items along with other valuable items.

That the value of lost/damaged properties is around Rs.20,69,800 only.(Rupees Twenty lakhs sixty nine thousand and eight hundred only). The details of my burn properties are enclosed herewith a table.

That,the I could not report well time due to present law & other situation as well as we were displaced and stranded. I am taking shelter at Relief Camp Wangoo Laipham Govt. Primary School Kakching District, Manipur. From 29<sup>th</sup> May 2023 along with my family members till date.

I therefore request you to kindly investigate and take up necessary legal actions. In this act of your kindness I shall ever remain and thankful to you.
