



I, the undersigned have the honour to state that a large number of Kurki Militants groups stormed and burnt down my house and all the inhabited areas of Seron Awang Leeka on 28th May, 3:00 am. In the incident, we have lost and burnt down the following items of property:

Wood 150 KB plus, 4. 2 Nos of Yengon shed and 1 cow shed, 5. 7 Nos of cattle and 9 Almirahs (wood), 1 Iron Godry, 7. 4 Nos of colour T.V. set, 8. CCTV Camera, 9. 2 Nos of Truck and 2 Nos of Tractors with trailers, 10. 2 Nos of paddy cutter, 11. 2 Nos of Electric Generator, 12. 1 No of Big Boat, 13. 2 Nos of Seminars & Car mat, 14. 60 Nos plastic chairs, 15. 1 mike & speaker, 16. 15 Nos of Mohor gold listed, 17. All the whole Sale Shop selling (Grocery cost est Amt. 40 lakhs), 18. in cash Rs 200,000/- (two lakhs), 19. 1 No of A Boat with Rs 6 lakhs (Kuchon Enterprise Machine), 20. 1 No of A-star Car and vehicle, 21. 20 Nos of Korphu, 22. 200 Nos different utensil, 23.
