



Sir,

I have the honour to state that I was staying in a rent house of Abujam Ojit Meitei (50) S/o (L) A. Sama Meitei of Tangjeng Khunou located at Sugnu Bazar opposite Sugnu Higher Secondary school since 10 year back. On 28/05/2023 at 11: 00 am, my rented house was burnt down by large numbers of unknown miscreants suspected to be Kuki militants and their supporters. In that incident, lots of my household properties were burnt into ashes. Particulars of the burnt items (1) 2 Nos. of Wooden Almirah and 1 No. of Iron Godrej worth Rs.90,000/-, (2) 3 Nos. of Wooden Bed worth Rs.35,000/-, (3) 2 Nos. of Fridge worth Rs.40,000/-, (4) 2 Nos. of electric heater worth Rs.18,000/-, (5) 4 Nos. of Gas cylinder and 1 No. of Gas stove worth Rs.18,000/-, (6) 1 Nos. of Washing machine worth Rs.18,000/-, (7) 1 Nos. of TV flat worth Rs.52,000/-, (8) 1 Nos. of Dressing Table worth Rs.10,000/-, (9) Ornaments worth Rs.8,00,000/-, (10) Money in cash Rs.14,00000/- . Total value of all items is estimated to be Rs. 24,81,000 (Twenty four lakh and eighty one thousand) approximately. I could not report in time due to prevailing law and order situation of our state.

In this regard, I request you to take up necessary legal action at the earliest.
