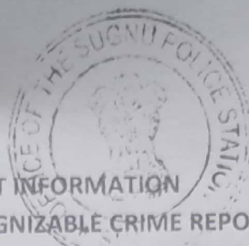





Sir,

I have the honour to state that on 28/05/2023 at about 11:00 am, my house cum cement store located at Sugnu Lamhang village near Post Office, Sugnu was burnt down by large numbers of unknown miscreants suspected to be Kuki militants and their supporters. In that incident, lots of my household properties were burnt into ashes. Particulars of the burnt items (1) Building house worth Rs. 20 lakh, (2) Iron rod Worth Rs. 5 lakh, (3) Cement worth Rs.10 Lakh, (4) 2 Nos. of wooden bed worth Rs.50 thousand, (5) 4 Nos. of Gas cylinder and 2 Nos. of Gas stove worth Rs.18 thousand, (6) 1 No. of Washing machine worth Rs.12 thousand, (7) 1 No. of 32 " TV flat worth Rs.25 thousand, (8) 1 Nos. of Almirah worth Rs.45 thousand, (9) 1 No. of Fridge worth Rs.30 thousand, (10) Clothing worth Rs.30 thousand, (11) Solar worth Rs.14 thousand and (12) 3 Nos. of Fan worth Rs.12 thousand. Total value of all items is estimated to be Rs. 37,36,000/- (Thirty seven lac and thirty six thousand) approximately. I could not report in time due to prevailing law and order situation of our state.

In this regard, I request you to take up necessary legal action at the earliest.
