



Sir,

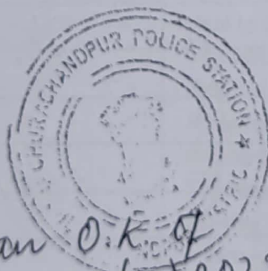
I am to bring to your notice that on the 4th May, 2023 at 3:00 PM
