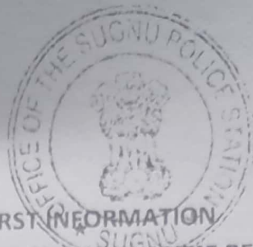


Sir,

I have to report that on 05-06-2023 at about 5.p.m. my show mill cum veneer situated at Serou Lamkhai was burnt down by some unknown person during communal violence between Meitei and Kuki community. As a result of which the following articles/ property has totally damage/ loss 1) one shaw mill machine, 2) one veneer machine, 3) one boiler (driyer), 4) one generator, 5) 20 electric motors, 7) constructed iron shed of 110 fts breath and 22 fts length, 8) One electric transformer of 250 kets, 9) 15 thelas, 10) vanner of 6,50,000 (six lakhs fifty thousand square meter), 11) 10,000 (ten thousand cubic feet of round log woods), 12) 20 (twenty) residence room. Total loss of about a sum of Rs 4,50,00,000 (rupees four crores fifty lakhs) being the value of the above mentioned articles: property was damaged in the said crime.


It is therefore report you to kindly take-up legal action against the unknown accused person as per law.
